# 1. Description

The XFP module is compliant with the 10G Small Form-Factor Pluggable (XFP) Multi-Source Agreement (MSA), supporting data-rate of 8.0~11.1Gbps, and transmission distance up to 80km on SMF.

The transceiver module comprises a transmitter with 1470~1610nm CWDM Cooled EML laser and a receiver with an APD photodiode. Transmitter and receiver are separate within a wide temperature range and offers optimum heat dissipation and excellent electromagnetic shielding thus enabling high port densities for 10 GbE systems.





The transceivers provide serial ID memory contents and diagnostic information about the present operating conditions by the 2-wire serial interface (SCL, SDA).



The digital diagnostic memory map specific data field defines as following:






# 7. Recommended Host Board Power Supply Circuit

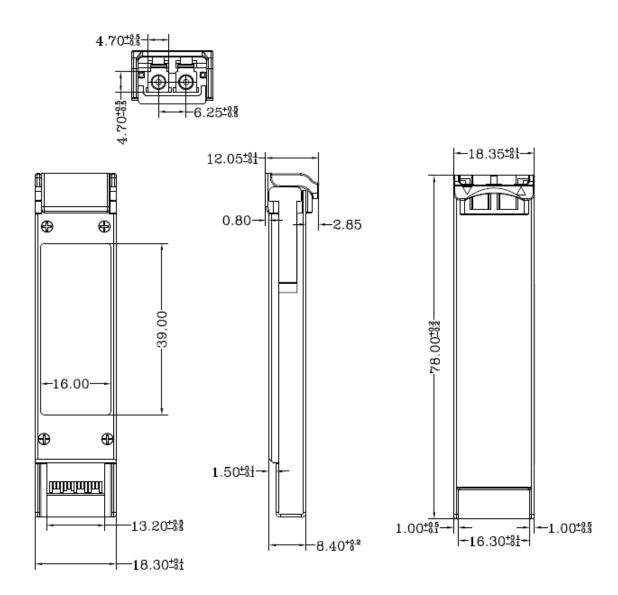


# 8. Recommended High-speed Interface Circuit
